## HOSTEL RULES & REGULATIONS

From the day of admission to the hostel, all inmates will be under the care and love of the concerned Warden and Matron. The following rules and regulations are applicable to inmates and their parents as well.

Hostel rules are intended to develop good and healthy habits among students. Students as well as their parents should be aware of these rules and follow them strictly.

1. Students and their parents should sign the hostel application form along with the rules and regulations.
2. Three passport size photographs of the student should be submitted along with the hostel application.
3. At the time of admission students are required to remit school admission fees and quarterly hostel fees as per the fee chart provided.
4. Those who have any inconvenience to pay the fee in time may deposit enough amounts in their ward's account in advance.
5. Bank Draft/ Cheque should be drawn in favour of Calcutta Public School, Ormanjhi.
6. Bedding, Pillows, Bed Sheet, Cot & Bucket will be provided in the hostel. However students should bring their own blanket (1), bath towels (2), dress hangers (10), tooth-paste, tooth-brush and soap.
7. Parents should give the detailed list of persons likely to visit their wards in the hostel and escort them home during holidays. Students will not be permitted to leave the campus without an escort unless parents make a special request to do otherwise..
8. Parents should take prior permission from the warden to meet their wards. Visiting time is between 2 p.m. to 4 p.m. Parents are requested to restrict their visits to Sundays and other holidays.
9. Students should not receive visitors or go out of the hostel without the permission of the warden.
10. Hostel reception room is the only venue for receiving visitors and no visitors will be permitted to enter any other parts of the hostel.
11. Students can be taken home at 4.30 pm on second or third Fridays. They should come back early enough to attend the class on the next working day. However parents are requested not to take their wards away to attend marriages and other unimportant functions.
12. Parents should get Exit/ Entry cards signed by the warden while going home and coming back after holidays.
13. Parents can call their wards by telephone between 9.30 pm and 10 pm in the numbers 9931847680 and 0651-2902740 for boys' hostel.
14. All telephone calls and letters to the students will be under the surveillance and control of the warden.
15. Inmates should not keep valuables and cash with them. Money transaction among the students will not be permitted.
16. Students should not keep more than five sets of dress other than their uniform, in the hostel.
17. Mobile phone, Walkman set etc. are banned in the hostel and will be confiscated if found on any students.
18. Students should keep modesty, decency and decorum in their behaviour, dress and hairstyle.
19. Students should not damage any property of the hostel or of the other inmates. Any one indulging in such activities will have to make good the loss in addition to facing other punishments. This will be levied individually or collectively as the case may be.
20. On demand from the head of the school, expenses towards the school fees, cost of stationery, study tours and excursions will be paid from the students' hostel account and the same should be remitted by the parents in the respective term itself.
21. Food will be provided as per the students' general interest and no catering will be done on individuals' option. Special nutritious drinks will be supplied on payment of the required charges there to.
22. Bringing food and other eatables to the hostel from outside is totally forbidden.
23. Medical treatment charges, if incurred at all, are to be paid by the end of that term itself.
24. Students suffering from infectious diseases or severe emotional syndromes will not be allowed to stay in the hostel. They will return to the hostel only after full recovery from their ailments.
25. Inmates should attend the morning and evening sessions of supervised study punctually. Extra hours provided for library access should be utilised by the inmates seriously and effectively to read the extensive collection of books and periodicals available in the library.
26. Hostel warden commands the authority to permit students to go on tours and excursions in the capacity as the guardian of the students.
27. Students should come back to hostel after holidays on the stipulated dates. Those who fail in doing so will be subjected to stern actions.
28. Decisions will be taken by the school and hostel authorities in the best interests and well being and development of the students and parents should comply with such decisions earnestly.
29. Students should strictly follow all school's rules and regulations.

**(Undertaking by Parents)**

1. I/We ..... do hereby undertake that I/we have read and understood the Hostel Rules & Regulations laid down by the School and agree to abide by them.
2. I/We hereby authorize the persons as stated on Page 1 of this form to act as Local Guardians for my / our son /daughter. I / We also delegate my / our responsibility to him and authorize him to take necessary decisions and actions in my/our absence.
3. I/We certify that my/our residential address and the Local Guardians address and contact details as mentioned on page 1 of this form are correct, in case of any change, I/we will intimate the same to the school management within 3 days.
4. My/Our ward will not indulge in any act of RAGGING. If he is found indulging in any such act or misbehavior, disciplinary action may be initiated against him as per the provisions of the Act No. IPC 326 (Serious Injury), 323 (Injury) and IT Act 67 (Vulgar SMS) & he may be expelled from the school if found guilty. If my/our ward is involved in any act of ragging, an FIR may be lodged against him.
5. I/We have gone through the prospectus and read through the fee structure and payment schedule. We agree to abide by them and strictly adhere to the payment schedule given. I/we will deposit the fees in full before the beginning of each term. The school fees and penalty, if any, which is due towards payment by me, will be paid within 30 days. If I/We default in making the payment, I / we are aware that, I/We will be asked to withdraw my / our ward. I / We will accept such a decision of the school authorities.
6. I/We have carefully read the "LEAVE RULES" of the institution Calcutta Public School, Ormanjhi. I/We understand that no leave will be granted to the students unless approved by the Principal. The gate pass will be issued only to me / us or to the authorized local guardians to take my/our ward, out of the hostel during regular week end outings/leave for special occasions.
  - a) Leave for attending marriage:
    - i) I/We understand that the application for leave to attend marriage will be supported by a marriage invitation card.
    - ii) I/We understand that in addition to the travel time, only two days leave will be permitted for the following cases:
      1. Marriage of real brother or sister. 2. Marriage of Parent's real brother or sister
  - b) Leave on account of death in the family:

I / We understand that such leave is permissible to offer condolence only in the. event of death of an immediate relative in the family.
7. I / We shall ensure that my / our ward will report back to the school on the assigned date as mentioned in the leave application. He will rejoin on the day the school reopens after vacations as per the dates specified in the school calendar. I / We understand that if my / our ward fails to join back on the assigned date, necessary disciplinary action may be taken against him as per the school rules & regulations.
8. I / We understand that my / our ward will be expelled from the school for any of the following act:
  - a. Using unfair means in the examination.
  - b. Consistent unsatisfactory performance.
  - c. Any act of Immorality as per social norms.
  - d. Grave insubordination
  - e. Stealing or extortion of money or any item from other students

- f. Contempt of authority
  - g. Leaving the hostel or school premises without prior permission. (Breaking the boundary rules)
  - h. Damaging school property
  - I. Any word, statement or action likely to undermine the reputation of the institution.
  - j. Bullying, assaulting and any act of ragging
  - k. Smoking, drinking alcohol and use of other psycho tropic drugs and substances.
9. I/We certify that all information related to the medical history of my/our ward is correct and complete. I/We understand that the school will do its best to provide routine medical aid, but will not be held responsible for any sickness/undisclosed disease. I/We understand that in case of communicable/infectious diseases, my/our ward will be sent back home. I/We / local guardian will pick him up from the hostel.
  10. I/We understand that in case of planned surgical procedures, we will duly inform the school authorities and formally apply for leave for my/our ward supported by all medical documents. I/We/Local Guardian will personally pick up our ward. My/Our ward will rejoin after complete recovery and a medical fitness certificate from the concerned medical practitioner will be submitted to the school authorities.
  11. If my/our ward leaves the school campus without permission, the school authorities may lodge an FIR with the local Police Station. I /We will have no right to question and raise objections to this action. The school will not be held responsible in the event of any accidental mishap or untoward incident in such circumstances.
  12. I/We will try to attend PTM as per the schedule given in the School Almanac. In case of my/our inability to do so, I/We will ensure that the Local Guardians attend the PTM on our behalf.
  13. I/We shall ensure that my / our ward will not carry any eatables, electrical gadgets,.
  14. I/We/My/Our family shall visit my/our ward only on the specified days stated in the visiting schedule for the Parents/Local Guardian.
  15. I/We will not visit the rooms of the students without proper permission from the Principal / Warden.
  16. I/We assure that I/We will extend full cooperation to the School authorities in the interest of my / our ward.

I/We have read the rules & regulations of the Calcutta Public School, Ormanjhi (Hostel & School) and agree to abide by them. items to the hostel & school. He/she will also not carry more than Rs. 500/- cash with him/her at any given time and  
the same will be at the custody of the warden who will monitor the expenditure.
